#### **MINUTES**

- CALL TO ORDER/INTRODUCTION DELAC Chairperson, Paola Granados, called the meeting to order at 12:01 p.m. and welcomed everyone to the meeting. Ms. Granados acknowledged and welcomed DAC and DELAC members from several school sites prior to the Superintendent's report to the Committee.
- 2. **SUPERINTENDENT'S REPORT** Superintendent, Dr. Francisco Escobedo, greeted the Committee then proceeded to share his report on the District. Dr. Escobedo informed the District continues with distance learning with over 1,100 students attending school under the distance learning support curriculum. Dr. Escobedo shared a data by zip code document provided by the San Diego County Office of Education regarding COVID-19 case counts. CVESD currently services seven zip code sectors in Chula Vista. The data by zip code showed that cases were increasing and not decreasing. SDCOE provides this data every Tuesday morning and will try to have this posted on the website. District staff will continue to monitor data very closely in hopes of bringing students back under a hybrid environment. In the meantime, District staff will begin preparations for safe classroom learning environment.

A committee member inquired if the District will continue to open on October 26. Dr. Escobedo responded that based on the current rise of COVID-19 cases and as per the Centers for Disease Control (CDC), the District will not be opening on October 26.
