MINUTES

1. CALL TO ORDER/INTRODUCTIONS

DELAC Chairperson Pedro Carrillo welcomed everyone to the DAC/DELAC meeting and called the virtual meeting to order at 12:01 p.m.

2. SUPERINTENDENT'S REPORT

Superintendent, Dr. Eduardo Reyes, welcomed parent leaders and expressed his thanks to parents, principals, and to community members who do so much for our students, our schools, and for the District. Dr. Reyes reminded there is only a month and a half of school and that there is still so much to do; that to get to a better place we need to continue working together and collectively to support the goals the District has put in place.

3. DISTRICT ADMINISTRATORS' REPORT

Mr. Oscar Esquivel, Deputy Superintendent, reported the Board of Education approved the District's Second Interim Budget Report at its March 9 meeting, adding the San Diego County Office of Education recently approved the District's Second Interim Budget Report as well. The District now waits on the May Revise to make any changes to the District's 2022-2023 budget based on the Governor's proposed budget shared in January. Mr. Esquivel made the following announcements: The April 20 Budget Advisory Committee (BAC) meeting has been adjourned to May 25 and enrollment is now open for Transitional Kindergarten, Kindergarten, and for new students. Enrollment is available online or can be done at their neighborhood school.

Assistant Superintendent for Human Resources, Mr. Jason Romero, informed the mask option for students and staff has gone well, and with regular testing the District is mitigating any chances of having a mass spread. Mr. Romero announced the following promotions approved by the Board of Education: Senior Director, Human Resources (Dr. Angela Rosendale); Senior Director, Student, Family, Community and Instruction (Ms. Lisa Forehand); Senior Director, Curriculum and Instruction (Mrs. Rochelle Carroll); and Salt Creek Principal (Ms. Gloria Velarde). A new search for principals will be taking place and Mr. Romero invited parents and community to provide input on what they are looking for in a principal.

Assistant Superintendent, Innovation and Instruction, Dr. Matthew Tessier reminded participants that questions received by the school community regarding the Local Control and Accountability Plan (LCAP) will be addressed by the Superintendent at the May 17th DAC-DELAC meeting before the LCAP is taken publicly to the Board of Education at its May 18 meeting for a public hearing. Executive Director, Ms. Lalaine Perez, updated on the English Language and Proficiency Assessments of California (ELPAC) and proudly reported the District is at 94% completion and is ahead of schedule and is confident the District will reach 100% completion in the next several weeks. Ms. Perez expressed thanks to principals, associate principals, teachers, impact teachers, EL IAs and support staff for this huge endeavor.

Ms. Perez reminded parent leaders that it is testing season and that all students will be participating in Local Measures assessments; Grades 3-6 will be taking the California Assessment of Student Performance and Progress (CAASPP) English language arts and math assessments; and Grades 3-6 students in DLI programs will be taking the California Spanish Assessment for the first time as a District. Parent leaders should contact their respective school principal if they have questions regarding the testing schedule

4. CHAIRPERSONS' REPORT

Mr. Baker, along with the Executive Board and the Superintendent are excited to announce beginning in May, DAC-DELAC will resume meeting in-person at the District's office. Meeting will take place in Room C at the Education Service and Support Center (ESSC), 84 East "J" Street, Chula Vista, CA 91910. End of year certificates will be presented. A light lunch will be provided.

Dr. Carrillo announced that Executive Officer elections will be held during this meeting for the following positions: DAC Vice Chairperson, DAC Board Member, DELAC Vice Chairperson and DELAC Board Member. Dr. Carrillo invited parent leaders to consider becoming a part of the Executive Board and to nominate themselves during the election process.
